Our goal is to provide a safe and accident-free environment; however, in the event of any injury, I release Concord Dance Academy and the instructors from all liabilities. I have read and voluntarily sign this release form.

FINANCIAL RESPONSIBILITY I accept full financial responsibility for all related costs during the 2026-2027 dance season at Concord Dance Academy. These costs include registration, monthly tuition, late fees (if applicable), costume expenses, and recital fee expenses. I understand that if my account becomes delinquent, the student will not be able to participate until the account is current. I understand my monthly tuition payment is for the entire month, regardless of the number of classes held. If a class is not held for any reason, no refunds will be given. I understand that there is no reimbursement of costume deposits or balances after they have been charged. Dancers who withdraw may pick up their costumes in the spring. I understand that makeup classes are available. I understand that payments are due by the 1st day of each month and a \$30 or 10% balance (WHICHEVER IS GREATER) late fee will be added to my account for all late payments. I understand that a card must be on file in my Studio Director account and enrolled in autopay.

ENROLLMENT I accept full responsibility for informing the office, in writing, if my student's enrollment for any class changes at any point during the season. If not notified in writing before an upcoming tuition payment, I understand that tuition will not be refunded. I understand that I am responsible for all costs associated with the class until the day I notify the office of said change.
